



## INVITATION TO BID FOR THE Procurement for Supply and Delivery of Safety Jacket, Field Shoes, Utility Back Pack and Umbrella

1. The Environmental Management Bureau Region IVA (CALABARZON) - DENR, through the National Expenditure Program 2022 intends to apply the sum of One Million Eight Hundred Twenty Four Thousand Pesos (PhP 1,824,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for **Procurement for Supply and Delivery of Safety Jacket, Field Shoes, Utility Back Pack and Umbrella** Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Environmental Management Bureau Region IVA (CALABARZON) - DENR now invites bids for the **Procurement for Supply and Delivery of Safety Jacket, Field Shoes, Utility Back Pack and Umbrella** Delivery of the Goods is required within Thirty (30) calendar days upon receipt of the Notice to Proceed (NTP) or the Letter Order (LO). The supplier should inform Environmental Management Bureau Region IVA (CALABARZON)-DENR at least three (3) days before the date of delivery. The delivery will be made only during working days and hours. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
4. Interested bidders may obtain further information from Environmental Management Bureau Region IVA (CALABARZON) – DENR and inspect the Bidding Documents at the 6<sup>th</sup> Floor DENR by the Bay Building (1515 L & S Building), Roxas, Boulevard, Ermita Manila during 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be purchased by interested Bidders on 6 December 2021 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of One Thousand Eight Hundred Pesos (PhP 1,800.00). It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The Environmental Management Bureau Region IVA (CALABARZON) - DENR will hold a Pre-Bid Conference dated December 13, 2021 10:00 am at 6<sup>th</sup> Floor, DENR by the Bay Building (1515 L & S Building), Roxas Boulevard, Ermita, Manila and via on-line conference (Microsoft Teams).
7. Bids must be duly received by the BAC Secretariat at the address below on or before 27 December, 2021. at 2:00 pm at 6<sup>th</sup> Floor, DENR by the Bay Building (1515 L & S Building), Roxas Boulevard, Ermita, Manila, which shall be open only to all interested parties who have

purchased the Bidding Documents All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated.

Bid opening shall be on 28 December 2021 10:00 a.m. at 6<sup>th</sup> Floor, DENR by the Bay Building (1515 L & S Building), Roxas Boulevard, Ermita, Manila and via on-line conference (Microsoft Teams). Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Environmental Management Bureau Region IVA (CALABARZON) - DENR reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


